Questions:

1-12. Biographical information. Please enter requested information.

Note that in this context, **nationality=citizenship**.

13. Type of passport / Other Travel Document

Answer: You may circle **National Passport** / If you are an International Student, you should add: Residency Card/ I-20/ F-1 Visa, whichever is applicable

14. Passport Number

Answer: Displayed on your passport

15. Issued by

Answer: Displayed on your passport

16. Date of Issue

Answer: Displayed on your passport

17. Valid Until

Answer: Displayed on your passport

18. If you reside in a country other than your country of origin, have you permission to return to that country?

Answer: **This question is for Non-US Citizens only**; assuming your legal status in the country you reside in, you should mark "yes" and provide the number(s) and Exp Date(s) of each legal documentation: Residency Card, I-20, F-1 Visa

19. Current Occupation

Answer: **Student**

20. Employer and employer's address and telephone number. For students, name and address of school.

Answer: **(Florence): 129 days for SP10**

26. Other Visas (issued during the past three years) and their period of validity

Answer: Provide information accordingly (if applicable)

27. In the case of transit, have you an entry permit for the final country of destination?

Answer: Assuming your legal status/stay in Italy, the answer is **"yes"**. Your "entry permit" is first and foremost your **Passport**. Valid until, is your **expiration date**. Issuing Authority is **displayed on your Passport**.

Answer: **Study**

30. Date of arrival

Answer: (**Florence**): **9 January, 2010**

31. Date of departure

Answer: (**Florence**): **17 May, 2010 for SP10**

32. Border of first entry or transit route

Answer: This is your first transfer and/or first entry point, outside of the US, toward your final destination. In other words, your first transfer point outside of the US, within the Schengen States (**First transfer in [Schengen Area](#)**).

33. Means of transportation

Answer: **Air**

Answer: You may circle **"Cash"**, **"Credit Cards"**
Travel and/or Health Insurance. Valid Until **Answer: 31-Aug-10 for FIT Gallagher Koster Policy (or per your own alternate coverage)**

Be sure to complete numbers 45, 46, "Place and Date" and 48.

Important: You must sign and date the form in the presence of a notary public, who will then notarize the document with his/her stamp and signature.
